Once processed and approved, and upon receipt of the full fee payment you will be officially registered for the annual Holidays on Main event. Note: fee is non-refundable for any reason once you are accepted into Holidays on Main. The Wethersfield Chamber reserves the right to cancel the event for public safety or other extreme circumstances no payments or fees will be refunded. Accepted forms of payment: Check, credit card, money order, bank check.
- 2) All Vendors agree to defend, indemnify, and hold harmless the Town of Wethersfield, and the Wethersfield Chamber of Commerce, its officers, directors, employees, and volunteers from any and all injuries and damages to persons or property caused by any actions or omissions of business, its employees or volunteers while participating in, or exhibiting at the Holidays on Main to be held on December 1, 2022.
